

**AFFIDAVIT OF INTENT**


I, Bradley F. Champine, being duly sworn, hereby

state that I am at the present time a duly appointed, qualified and acting Assistant District Attorney General for the 26th Judicial Circuit of the State of Tennessee;

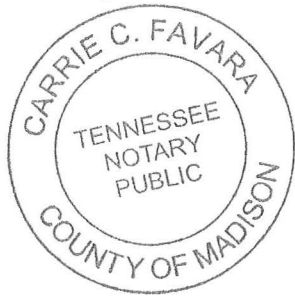
