


IN RE: APPOINTMENT OF DISTRICT ATTORNEY PRO TEM

ORDER APPOINTING DISTRICT ATTORNEY PRO TEM

Pursuant to Tennessee Code Annotated § 8-7-106(a), the Court hereby appoints Helen O. Young to serve as District Attorney Pro Tem beginning Wednesday, September 1, 2021, upon the vacancy created by the retirement of District Attorney General John W. Carney, Jr. Such appointment shall continue until such time as the governor shall appoint a suitable person to fill the office temporarily until the next biennial election takes place. The acts of such district attorney general pro tem shall be as valid as if done by the regular officer, and the district attorney general pro tem shall be entitled to the same privileges and emoluments.


It is so ORDERED.


